COURT AND JUDICIAL BONDS CHECK LIST

- 1.Application for Court and Judicial Bonds (attached). Please complete in full, dated and signed as indicated.
- 2.Current Personal Financial Statement (attached)
- 3.Business Financial Statement (if applicable)
- 4.Court documents (attach a copy of the court order for the bond; also all and any documents relating to the case)
- 5.Complete explanation from the applicant and/or attorney of the case (separate sheet please).
6. Bank verification (upon request)
- 7.If stop notice or mechanic's lien: provide complete information of contractor.

IMPORTANT: Many type of bonds may require collateral. Some acceptable forms of collateral are:

- 1.A cashier's check made payable to the surety company.
- 2.An irrevocable letter of credit (LOC) drawn on a bank acceptable to the surety.
- 3.A certificate of deposit or assignment of a certificate of deposit.
- 4.A deed of trust on real property.

That the Surety has the right to conduct such investigations of indemnitors including the examination of assets, books, records and credit history as the Surety deems appropriate.
